Subject: Decisions taken in the CHQ office bearers meeting – reg..

\ The CHQ office bearers meeting of the BTEU BSNL was held at Nagpur on 7th and 8th April 2018 under the Presidentship of Shri A.Ganesh esteemed President of the CHQ. Shri Soni Ji, Vidarbha Pradesh BMS General Secretary inaugurated the meeting. Shri Virjesh Upadhyay General Secretary BMS New Delhi was the chief guest. Shri K.Radhakrishnan, former President of the CHQ was also present on the occasion.

The meeting reviewed the functioning of the CHQ and has taken the following decisions to strengthen the union at all levels in the coming days.

I. Circle conferences:

The CHQ has been impressing upon the circles to conduct their circle conferences for the past several months but no action is taken by the circle secretaries so far. The meeting has directed the circle secretaries to conduct the circle conferences before the end of May 2018 positively.

a) Uttarakhand circle conference will be held at Dehradun in May 2018 date to be intimated by 25.4.18

b) Punjab circle conference to be held at Chandigarh in May 2018, date to be intimated by 25.4.18

c) Mahashtra circle conference to be held in May 2018, date & venue to be intimated by 25.4.18

- h) Shri Ganesh Mathpati AGS will tour MP Circle & Chattisgarh circle in May 2018


IV. Instructions regarding CWC Meeting:

V. News from CHQ:

- a) The DPE has sent its reply back to DOT on 18.4.18 regarding implementation of 3 PRC in BSNL. After receipt of the note from DPE, the DOT is in the process of moving cabinet note. The same is expected to be finalised before 1st week of June 2018.
- b) The status of Group B to Senior Accountants is also under active consideration of the Corporate office and will be settled in this month.
- c) The Corporate office was also asked to expedite the release of the results of the Departmental examination conducted for promote to JE cadre and the results are expected at any time. The corporate office has appreciated the efforts of the CHQ in pointing out the mistakes in the question paper and the expert committee has taken into consideration all the inputs given by the CHQ.
- d) The corporate office also is reviewing the results of the JAO 10% and JAO 40% examination held in 2016 as there are some anomalies left.
- e) A successful dharna / demonstration was conducted in front of the corporate office on 5.4.2018 over the issue of irregularities in the matter of transfers in AP & TS circles due to bifurcation of the circle.
- f) After the agitation, the CMD BSNL called a meeting on the same issue and assured to sort out the problems and asked the CHQ to submit a comprehensive proposal.
