Subject: JAO 40% exam held in July 2016 – declaration of result – reg.

Respected sir ,

This is regarding declaration of the result of the JAO 40% examination held in July 2016 in respect of Shr Y.Surya Somayajulu, Sr.TOA working in the West Godavari SSA of AP Circle. The brief facts of the case are as follows please.

1. The official has appeared in the JAO 40% Quota examination held in July 2016 and was declared as having qualified in the said examination and should first in the merit list in the circle.
2. However, the official could not be sent for training on the plea that he has acquired higher qualified from i.e. Mcom.from Madurai Open University.
3. Subsequently the official approached the Hon'ble CAT Hyderabad which permitted him to undergo the training. But despite that he was not considered for promotion to JAO Cadre.
4. There is a provision, during the year 2001, by Madurai Kamaraj University (may be in other universities also) that after 10 plus 2, candidates are given foundation material / course and after successful completion of test after foundation course only they are admitted into M.Com 1st year.
5. The said provision is withdrawn by the Govt of India through Gazette dated 11/07/2014 i.e. w.e.f 11/07/2014 (18th point on 18th page). Which inter alia means that after 11/7/2014 doing M.Com in that way i.e. after 10 plus 2 is not valid.
6. It is a fact that after seeing an advertisement from the Madurai Kamaraj University the official has approached BSNL for getting prior approval and got admission after getting approval (for studies) from the concerned authority in the year 2002.
7. It is also a fact that the official has completed his M.Com in the year 2006 and the same is entered in his service Book. It is also true that he have attended JAO part-II exam on 17/7/2016 and stood first in Andhra Pradesh and 3rd in All India.

It is therefore requested that the candidature of the official may kindly be considered and he may be declared as having qualified in the JAO examination held in the year 2016 due to the fact that he has acquired higher qualification as per the provisions of the UGC existing at that time, It is a different matter that the said provisions have been withdrawn by the Government now.
