Respected Madam,

This is regarding formation of circle office of BSNL in Andhra Pradesh Circle Vijayawada by bifurcating the existing circle office at Hyderabad.

2. A kind reference is also invited to BSNL Corporate office letter cited at reference 1 above wherein it is clearly stated that options from the neighboring SSAs of AP circle may be obtained for deputing the Group C & D employees into the new Circle office proposed to be set up at Vijayawada.

3. This union from the very beginning has been advocating that the options from the staff working in the various SSAs of AP circle and also Telangana circle be obtained so that only willing officials can be posted to work in the new circle office at Vijayawada. This plea of our union has been opposed by both the recognized unions at that time and they wanted only the officials working in Hyderabad to be transferred to Vijayawada.

4. Our repeated pleas with the BSNL management and also with the Hon'ble MOC were not considered and about 30 employees from Hyderabad CGMT Office were transferred to Vijayawada and they were relieved at the behest of both the recognized unions by force. **It may not be out of place to state here that in the National Council Meeting held in the corporate office during May 2017, the Vice President of the BSNLEU who is also the Circle Secretary in AP circle took up this issue as an out of agenda item and prevailed upon the management to see that all the officials who were transferred from Hyderabad to Vijayawada are relieved forthwith.**

5. Out of these 30 officials 2 officials were retained in Hyderabad due to the reason that one is a physically challenged person and another was to retire in September 2017. Our plea to consider the cases of some other officials also who are due for retirement within 2 years (2 men and 3 Women) were not headed and the

case of one of the official who met with a road accident was also not considered and all of them have since joined at Vijayawada.


6. Now the CGMT Hyderabad has issued transfer orders for another set of 10 officials vide letter cited at 2 above which includes the District Secretary of the recognised union and a case is now being made out for his retention under immunity which is not tenable as the transfers are effected basing on bifurcation policy.

7. It is also understood that the main recognized union is now propagating that the officials working in the other SSAs of AP circle should be posted to the CGMT Office at Vijayawada. This stand was taken by this union from the very first day and this fact was opposed tooth and nail by both the recognized unions and in the very first meeting convened at the CGMT office Hyderabad to workout modalities for bifurcation of the circle it was recorded in the minutes that only staff working in Hyderabad are to be transferred to Vijayawada. ***This shows that the recognized union changes its colors as a chameleon does just to protect its office bearers.***

8. We would therefore request that the entire issue be revisited immediately and all the officials who are transferred to Vijayawada from Hyderabad be brought back to the CGMT Office Hyderabad and the options be called for from the staff working in the various SSAs of AP & TS Circles and they be posted in the CGMT Office at Vijayawada.
