Sub: Request for re-evaluation of all the answer scripts of JAO LICE 10% exam held on 24.9.16 in view of discrepancies.

Respected Madam,

A kind reference is invited to this Union's letter of even no dated 8.11.2016, 6.2.2017, 20.3.2017, 12.4.2017, 12.6.2017, 11.7.2017, 7.11.2017 and 15.12.2017 wherein we have brought to your kind notice about the discrepancies in the manner of questions set and wrong options given to the candidates who have appeared in the JAO LICE held on 24.9.2016 against 10% quota.

We would like to submit the following few lines for your kind consideration and favorable action please. Many of the officials have appeared for JAO (LICE) 10% Exam held on 24/09/2016 and a few were declared as qualified as per the Merit list declared on dated 02.11.2016. It is surprising to note that the question paper given to the candidates in the 10% quota exam was similar to the one given to the candidates who have appeared for the JAO exam held under 40% quota in July 2016.

We have noticed that there is ambiguity in at least two questions found in the question paper-I (Part B) online Exam held on 24.09.2016. Since there is provision of negative marking, many have not attempted these questions. For this reason only a few could not qualify in the said paper and to be precise only 7 officials are left from our the several who have appeared in the examination. The details of the ambiguity nature of the questions is as per the Annexure appended here with.

Therefore, we earnestly request your kind self to consider the discrepancies (as listed in Annexure) and give suitable instructions to the concerned to cause suitable remedial measures so that required relief is made available to such of the officials who have not qualified in the examination at an early date.
