Respected Madam,

This is regarding discrepancies in the manner of questions set and wrong options given to the candidates who have appeared in the JAO LICE held on 24.9.2016 against 10% quota. This union has been taking up this case since 8.11.2016 onwards quite frequently and the matter remains unresolved even though there are clear discrepancies in the question paper. The facts of the case are as follows please.

We would like to submit the following few lines for your kind consideration and favorable action please. Many of the officials have appeared for JAO (LICE) 10% Exam held on 24/09/2016 and a few were declared as unqualified as per the Merit list declared on dated 02.11.2016. As on date only 7 officials are awaiting for a review of the result due to the discrepancies in the paper.

We have noticed that there is ambiguity in at least two questions found in the question paper-I (Part B) online Exam held on dated 24.09.2016. Since there is provision of negative marking, many have not attempted these questions. For this reason only a few could not qualify in the said paper. The details of the ambiguity nature of the questions is as per the Annexure appended here with.

Therefore, we earnestly request your kindness to consider the discrepancies (as listed in Annexure) and give suitable instructions to the concerned and cause suitable remedial measures so that required relief is made available to such of the officials who have not qualified in the examination at an early date.


