Subject: Notice for agitation – One day Mass Hunger Strike at BSNL Corporate office – reg.

Sir,

We are very much constrained to state that the Bharatiya Telecom Employees Union (BSNL) has been taking up with the BSNL Corporate office Management at various levels and also with the Circle Heads for more than one year on some of the following issues concerning the non executive employees and that there has been no progress in the matter of settlement of any of the issues.

Left with no other alternative, the Central Secretariat of the Bharatiya Telecom Employees Union (BSNL) has decided to organise a mass Hunger Strike in front of Bharat Sanchar Bhavan, Janpath New Delhi for one day on 12.8.2016 for settlement of the issues cited herein.

1. Irregular implementation of Transfer policy guidelines in the circles with particular reference to Andhra Pradesh circle (Prakasam / Krishna / West Godavari & Khammam SSAs)
2. Transfer policy is not implemented uniformly in all the circles in BSNL.
3. Grant of cash award to outstanding sports persons in the circles
4. Wrong implementation of ACP guidelines for Stenographers cadre in AP Circle
5. Promotion under NEPP in Sawaimadhopur SSA of Rajasthan circle
6. Regularisation of services of Shri Jagannath Shenpadu Patil, TM OFC Dhule, MH Circle
7. Selection Grade to Lift Operators in West Bengal Circle
8. Conversion of Part Time Casual Labour into Full Time Casual labour wef.1.10.2000.
9. Officials working in the pay scale of Rs.9020-17430 to be made eligible to appear in the JTO LICE.
10. Regularisation of services of Officiating Jr. Accounts Officers in the field Units.
11. Award of Grace Marks to the officials failed in the JAO Part II Examinations
12. Revision of HRA to the employees from 68.8 % of IDA to 78.2% of IDA.
13. Payment of Bonus for the years 2014-15 and 2015-16
14. Payment of BSNL MRS amount without vouchers to the staff.
15. Restoration of Leave Travel Concession to the BSNL Employees.
